INTEGRATION TO THE CO-RESPONSIBILITY AGREEMENT BETWEEN I.C. PAOLO AND LARISSA PINI AND THE FAMILIES OF ENROLLED PUPILS ABOUT ORGANIZATIONAL, HYGIENIC-SANITARY MEASURES AND INDIVIDUAL BEHAVIOUR AIMED TO CONTAIN THE SPREAD OF COVID-19

In particular, the Parent or Legal Guardian declares:

• to know the rules to prevent the infection as of today; • that their child or those who belong to the same household are not under quarantine or that they are not positive for COVID-19; • that nobody in their family has had close contact with people tested positive for COVID-19 in the last 14 days; • that nobody in their family has travelled abroad through high-risk countries in the last 15 days; • to commit to communicate immediately if any symptoms of COVID-19 appeared or if one of the conditions already quoted appeared; • to commit to keep their child at home in the presence of fever (equal to or greater than 37.5° C), sore throat, nasal congestion, conjunctivitis, loss of smell or taste and to let the Pediatrician and the Headmaster know about the appearance of symptoms or fever; • to know that at the school entrance the temperature will not be measured and that this control is a parental duty, with penal consequences; • to be aware and to accept that their son, in the presence of fever equal to or greater than 37.5° C or of any of above-mentioned symptoms, will not be allowed to stay at school; • to be aware and to accept that, in the presence of fever equal to or greater than 37.5° C or of any of above-mentioned symptoms, the Headmaster will provide immediate isolation of the pupil and inform the Department of Public Health and their family. While waiting for COVID-19 test results, the Department of Public Health will lay down the management measures and the precautions to be taken, including the immediate removal of the symptomatic pupil, by their parent or guardian; • to be aware that in case of unavailability, the school staff will call an ambulance to ensure the immediate removal from the school of the symptomatic pupil; • to be aware that their son is requested to respect hygienic-sanitary rules within the school• to have been informed by the Headmaster of all the organizational and hygienic measures for safety and risk containment of COVID-19, and in particular: • of the meaures regarding entry to school and exit from school • to be aware that parents and guardians are not allowed to access school, except for emergency situations and with the permission of the Headmaster; • to commit to adopt the utmost care also when not at school, to prevent contagion; • to be aware that when the usual school interaction activities restart, even controlled, the risk cannot be removed, it can be reduced to a minimum, through the scrupulous

and strict observance of the precautionary and safety measures, planned by specific protocols for the carrying out of activities; for that reason it is important to observe the outmost caution also out of school; • to encourage the carrying out of all school activities, ensuring attention and active participation both in the usual classroom learning and in distance learning; • to observe the rules - particularly for safety and privacy - regarding the use of the web network and of the technological tools used in the possible carrying out of distance learning activities which are described in 'Piano di Didattica Digitale Integrato- Integrated Digital Teaching Plan' attached to PTOF-Educational Offer and published on the school website; • to take part in school activities by visiting regularly school website and by checking and using the electronic class registry.

In particular, the I.C. declares that:

- it has provided thorough information on every organizational and hygienic-sanitary measure adopted in order to contain the spread of COVID-19 and that during the period of school attendance it will communicate any change or addition to the arrangement;

- the teaching and non-teaching staff have been properly trained on all areas of the current regulations concerning hygienic-sanitary policies and procedures aimed to prevent and contain the spread of the virus. The staff is committed to strictly comply with all hygienic-sanitary procedures and to go to work only in the absence of any symptoms related to COVID -19;

- it is committed to adopt all hygienic-sanitary measures required by the current legislation, and in particular the rules regarding social distancing;

- the teaching and non-teaching staff will responsibly take care of the hygienic-sanitary and safety measures for all non-self-sufficient pupils;

- it will not promote activities involving gatherings of students;

- in the case of COVID -19 infection of a pupil or adult, it will strictly and thoroughly adhere to all orders of the health authority;

- it will guarantee the educational offer safely, providing also, if needed, the use of distance learning, conforming with the environmental and organizational conditions of the school and in accordance with the competent authorities;

- it will guarantee maximum transparency in administrative acts, clarity and timeliness in communication, also through IT tools, thus ensuring respect of privacy.

The signing of this agreement commits the parties to respect it in good faith. From a legal point of view, it does not free the subjects who sign it from any liability in the event of failure to comply with the regulations relating to the containment of the Covid-19 epidemic, the ordinary regulations on safety in the workplace, the Guidelines for planning school activities, educational and training courses in all institutions of the National Education System for the school year 2020/2021.
